- Centralised Trial for each Game will be conducted against the posts of Pay Level 2/3 & Pay Level 4/5 and separate Centralized Trail will be conducted for the posts of Pay Level 1. Hence, the applicants should apply at one place against the post of same Pay Level as the centralized trial will be conducted.
- Period of Reckoning Sports Achievements:- For recruitment against sports quota. the sports achievements shall be in the current and/or immediate previous 02 (two) financial years.

For example, the Employment notice issued in 2024-25 (i.e. from 01.04.2024 to (2024-25) and previous two financial years. i.e. 2022-23 and 2023-24 shall be taken into account and therefore, sports achievements on or after 01.04.2022 shall only be considered for appointment in the extant case. For this purpose, concluding day/date of the Tournament/Championship shall be taken into account.

4. Age Limit: The age limit will be 18-25 years. (The age of sports person will be reckoned as on 01.01.2025). No relaxation in upper or lower age limit will be

5. Minimum Educational Qualification for recruitment:-

- For the post of Pay Level 4/5 Minimum Graduation in any Discipline from a recognized
- For the post of Pay Level 2/3- Passed 12th (+2 stage) or its Equivalent Examination OR Passed Matriculation plus Course Completed Act Apprenticeship OR Passed Matriculation plus ITI approved by NCVT/SCVT OR Passed 10th from a recognized Board may also eligible to be posted as Tech-III. However the training period for appointees will be 03 years unless they pass /possess ITI in the relevant trade in which case it will be 06 months.

Refund of Examination Fee will be made through Bank Account; hence candidate must submit RTGS form as shown in annexure-'A'. *Economically Backward Class candidates means whose family income is less than ₹ 50,000 per annum. They have to produce income certificate in the prescribed format as shown in annexure-'B'. IPO (Indian Postal Order) should be pledged in favour of 'FA&CAO, East Central Railway' and payable at Hajipur. Except as stated above, examination fee is not refundable under any circumstances.

8. Medical Examination: The sportsperson (Male/Female) to be appointed shall fulfill the minimum medical norms after examination by Railway Medical Authority for the post for which he/she has to be considered for appointment.

9. Procedure for Recruitment:

Selection will be based on performance in Trial, evaluation of Sports achievements, evaluation of Educational Achievements etc. as per rule/istruction of Railway administration. Only the candidates declared FIT in the Trial will be considered for next stage of selection. No marks shall be given to the candidates who declared UNFIT in the Trial for their sports achievements, etc. No communication shall be entertained from candidates in this regard.

- Note:- (i) The candidate may have to stay for 2-3 days during TRIAL for which he/she has to make his/her own arrangement. No TA/ DA/Accommodation will be provided Applications addressed to any other official except as given above, should be summarily for attending seletion procedure.
 - (ii) Dope test can be done if need arises.
 - (iii) Videography will be conducted of all field trial to maintain transparency.
 - (iv) Date, venue and time of Trial will be intimated to the eligible candidate by post and will also be posted on our website. Candidates are advised to keep track on our website. 10. Conduct of Trial:

(i) Trial of candidates shall be conducted to assess their sports performance/ suitability for the team of E. C. Railway. Candidates found FIT in the Trial will be considered for next stage selection. The following is the format of marks for the

- (ii) After Trial only the fit candidates shall be considered for the next stage i.e. document verification. Only candidates declared FIT in Trial and attending document verification shall be awarded the marks for the sports achievements, educational qualifications etc. No marks shall be given to the candidates declared UNFIT in the Trial for their sports achievements etc. No communication shall be entertained from candidates in this regard.
- (iii) Distribution of Marks: Maximum marks which can be awarded in the Trial and Assessment of Sports Achievements/Educational Qualificationduring interview shall be as follows:-
