On satisfactory Completion of the contract period of 01 year, the contract may be extended on availability of vacancy and on the recommendation of Chief Medical Superintendent/DLI. The retired Government Doctors can be engaged for 01 Year up to 65 years of age, Retired Government Doctors are also invited in walk-in Interview for engagement on contract basis. 3. Nature of Engagement

The engagement is purely on contractual basis for 01 year or till regular UPSC selected Doctor becomes available, whichever is earlier. Further, the service of these doctors is also terminable before the expiry of contract period, if services of CMP Doctor is found to be unsatisfactory or in case of any indiscipline. The service will be rendered as contract doctor is a stop gap arrangement. It will also not confer any right for automatic regularization/absorption in any circumstances, whatsoever it may be.

a. For GDMO:-

MBBS from a recognized university and must have completed rotatory internship for one year and should be in possession of a valid registration certificate of any of the State Medical Council.

Walk in interview, Suitable weightage will be given to academic qualification and experience.

7. Other Facilities

Contract Medical Practitioner can avail free medical treatment for self only.

Expenses on out station journey connected with contract work will be borne by the daily allowance at specified rates admissible.
