**\*AGE RELAXATION:** The upper age limit will be relaxable for ST candidates by 5 years. For candidates who belong to PwBD category having minimum 40% disability or more will get 10 years relaxation in upper age limit in addition to the relaxation applicable to the categories mentioned above. **TERMS OF ENGAGEMENT & REMUNERATION:**

**Project Engineer-I** will be engaged initially for a period of **Three** years which may be extended up to maximum of **ONE** year (**Maximum tenure of 4 years**) based on requirement and individual performance. Candidates will be paid a consolidated remuneration as follows:

**MODE OF SELECTION**

- Selection will be through a written test followed by interview of only those candidates who qualify the written test will be called for interview in the ratio of 1:5 in the order of merit in each category.
  - Written Test will consist of objective type questions for 85 marks from Technical domain and General Aptitude.
  - All candidates shall secure 35% (GEN/OBC/EWS) and 30% (ST/PwBD) as qualifying marks in written test.

- The assessment weightage will be 85% and 15% for written test and interview respectively.
- Call letters will be sent to the e-mail IDs of eligible candidates for attending the written test. BEL will not be responsible for bouncing of any e-mail sent to the candidate.
- Date, time and center details of the written test will be intimated by e-mail in due course.
