- **6.SPORTS ELIGIBILITY:** The meritorious sports persons will be considered for appointment based on the following criteria:
- I) Sportsmen who have represented a State or the country in the National or International competition; or Medal winners in Junior National Championships; or Medal winners in Khelo India Youth Games (age category above 18 years); or Khelo India Winter Games; or Khelo India Para Games; or Medal winners in Khelo India University Games; or Medal winners in School Games Federation of India (SGFI) in any of the games/sports mentioned in Para 5.
 - For Chess: Grand Master (GM) Title, International Master (IM) Title, Chess Olympiad. IM/GM title should be in Open Category like Woman Grandmaster (WGM) etc. While National Open Chess Championship is treated as National Championships, the medal winning performance in National Team Chess Championship will also be considered.
- ii)Sportsmen who have represented their University in the Inter-University Tournaments conducted by the Inter-University Sports Boards in any of the sports/games specified in Para 5.
- iii)Sportsmen who have represented the State School Teams in the National Sports/games for schools conducted by the All-India School Games Federation in any of the games/sports mentioned in Para 5.
- iv)No such appointments can be made unless the candidate is, in all respects, eligible for appointment to the post applied for, and in particular, with regard to age, educational or experience qualifications prescribed under the Recruitment Rules applicable to the post, except to the extent to which relaxations thereof have been permitted in respect of class/category of persons to which the applicant belongs.

8. HOW TO APPLY:

Applications must be submitted only by online mode which can be accessed from the following URL: www.incometaxhyderabad.gov.in. Last date to submit the application online is on or before 05.04.2025.(5th April, 2025)

Note: Each candidate shall submit only one application form. Submitting more than one form may render one's candidature invalid.

- 9. The applicant shall upload attested copies of the following certificates:
 - (I) Matriculation/SSC or equivalent certificate for proof of age.
 - (ii) Certificates of Educational qualifications. (As per the requirements of the
 - (iii) Sports/games certificates as mentioned in Paragraph 7 above.
 - (iv) SC/ST/OBC community certificate.
 - Valid Proof of ID (Aadhar Card, Driving License, Passport, PAN Card or Voter ID)

The candidate must be in possession of the requisite qualification for the post concerned as on the date of his/her application.

- 16. The Pr. Chief Commissioner of Income Tax, Andhra Pradesh and Telangana region, has the right to cancel the recruitment process at any stage without assigning any reason and the Pr. 17. ADDITIONAL INSTRUCTIONS:

- In respect of appointment for the post of Stenographer Grade-II, the selected candidates will be required to qualify the Skill test. For this purpose, the Dictation test will be for 10 minutes @ 80 w.p.m and Transcription will be 50 w.p.m. (English) and 65 w.p.m. (Hindi) only on Computers, in accordance with the provisions of the relevant Recruitment Rules.
- In respect of appointment as Tax Assistant, the selected candidates will be required to qualify the Data Entry Skill Test @ 8000 key depressions per hour, in accordance with the provisions of the relevant Recruitment Rules
- The applicants are advised to visit www.incometaxhyderabad.gov.in from time to-time for more details and information.
- In case of any discrepancy regarding the wordings in the advertisement, the English version of the advertisement will prevail over the version in other languages.
- The selected candidates should produce relevant original certificates at the time when they are called for document verification.
